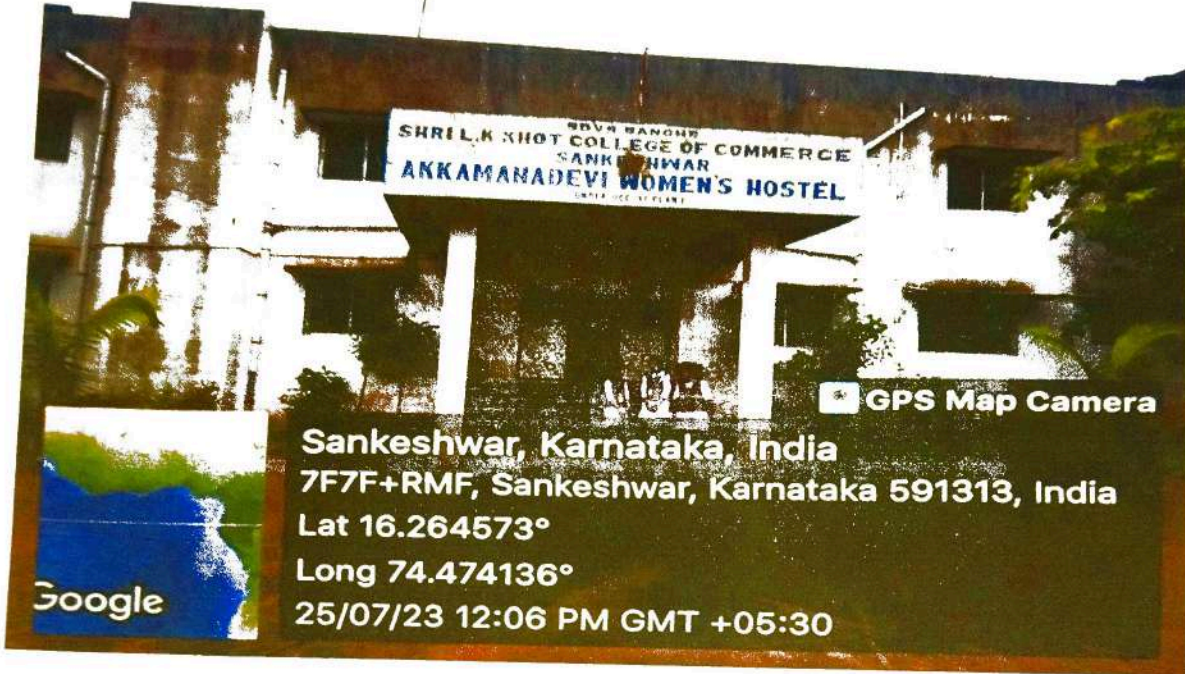

Anti-Ragging Cell

What is Ragging?

Ragging is a notorious practice wherein the students get an excuse to harass their junior and make them easy targets. Such as -

- A] Any act of indiscipline, teasing or handling with rudeness.
- B] Any act of physical abuse causing assault, harm or danger to health.
- C] Any act that prevents, disrupts the regular academic activity.
- D] Any act of abuse by spoken words, emails, sms or public insult etc.

Our college has constituted Anti-Ragging cell for preventing ragging.

Objectives of Anti Ragging cell :

- 1] To aware the students of dehumanising effect of ragging.
- 2] To generate an atmosphere of discipline by sending a clear message that no act of ragging shall be tolerated and any act of ragging shall not go unnoticed and unpunished.
- 3] To consider the complaints received from the students and conduct enquiry and submit report to the Anti-Ragging cell.

"Ragging is strictly prohibited in the college premises. If anybody found indulged in such kind of activities, strict action will be taken irrespective of the extent."

- 2] Interaction with senior students.

- 4] Installation of CCTV.

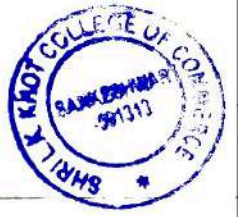
