




Organogram of S. D. V. S. Sangh's Shri L. K. Khot College of Commerce



- 1. The members of the teaching staff have to attend their duties in time.

- 7. Teaching staff shall compulsorily work up to 4.30 pm and Non-teaching staff shall work up to 5.30 pm.
- 8. In case a staff member needs to go out of the college for administrative work or any other important work shall record this in movement register with due permission of the Head of the Institution.
- 9. Menial staff need to wear Khaki uniform.
- 10. Mobile phone shall not be used during working hours.
- 11. Staff shall pay attention to cleanliness of campus, proper use of water and electricity.
- 12. Along with routine lectures teachers shall inculcate ethics and moral values among students.
- 13. Teachers shall honestly teach as per the syllabi prescribed by the university.
- 14. The teaching plan, work diary and attendance register shall be appropriately maintained.

- 15. Teachers shall make efforts to actively engage students in academic activities by giving homework.
- 16. Except language teachers other teachers shall not use books in classroom.
- 17. Teachers shall prepare notes related to their lectures using reference books in library.
- 18. Teachers shall encourage students to inculcate hobby of reading in library.
- 19. Teachers shall prepare model code to orient students to positive thinking.
- 20. Teachers shall make students realize that the goal of learning is to live a better life.
- 21. As evaluation is an important part of the teaching learning process, teachers need to set scrupulous question papers as per the blue print and prepare model answer sheets.
- 22. Teachers shall evaluate answer scripts with utmost care and return to the students in time.
- 23. Teachers shall adopt modern methods of pedagogy.
- 24. Teachers shall give importance to participate and present papers in national, international seminars, workshops and conferences.
- 25. Teachers shall pay attention to enhance their ability to teach and involve in research activities.
- 26. Teachers shall actively participate in all activities of the institute and guide students.
- 27. Teachers shall make efforts to upgrade their education and give preference to research oriented activities.
- 28. Teachers are governed by the service rules as envisaged by the Ministry of Higher Education, Government of Karnataka and need to follow the code of conduct set by the affiliating university and UGC.
